**COURT ORDERS**

**CONFIRMING THE VERDICT OF THE COURT**

In relation to the Statement of Claim presented this day by Juliette Teiermanis and on behalf of Zoran Kovacevic (Plaintiffs), a jury of their peers which consisted of twelve reasonably minded men and women, confirmed the following verdicts:

We the people find the Defendant guilty of committing fraud against the Plaintiffs and of unlawfully causing harm, injury and loss. Furthermore, unlawful dismissal causing hardship and extreme financial loss.



**It is hereby ordered** that after a unanimous decision of the court that the Defendant is liable for a financial payment of \$1.1 million for both Plaintiffs and furthermore to Plaintiff Juliette Teiermanis, a separate search and all legal documents requested in writing to be given inclusive of but not limited to breakdown of deposit; statement of separation/termination certificate, and MAXXIA packaging documents.

This payment is to be made directly to the Plaintiff and will cover compensation for the distress, harm and financial hardship caused by the unlawful dismissal.

This payment should also be paid within a period of twenty eight (28) days from the signed receipt of this order.

It is further ordered that the Plaintiff pay court costs of \$950.00 to be paid into the Common Law Court Foundation.

Any failure to comply with these orders may be a criminal offence under Common Law and a crime against the people. Should anyone involved fail to comply with these orders they will be prosecuted under Common Law as everyone is held personally accountable for their own actions, in their private capacity.

These Court Orders are effective as of this date and will remain in force until they are complied with.

These orders are also issued under the authority of this Common Law Court and jus gentium, the Law of Nations.
