### COURT ORDERS

CONFIRMING VERDICT OF THE COURT

In the matter of

**A Grand Jury indictment on behalf of the People in the State of  
Victoria (Plaintiff)**

v

**Martin Foley as a living man in your private capacity, Politician -  
Labor Party**

(Defendant)

In relation to the Statement of Claim presented this day by the people (Plaintiff), a Jury of his peers which consisted of twelve reasonably minded men and women, confirmed the following verdicts:

We the people find the Defendant guilty of committing fraud against the men and women guilty of misprision of fraud, unconscionable conduct in public office, misprision of treason knowing that Queen Elizabeth11 was unlawfully removed and the Constitution by the Act of 1986 keeping in mind ignorance of the law

is no excuse. In your position as Health Minister the jury found that your conduct contributed to the deaths of many people and your actions led to unnecessary duress and suffering under the guise of a pandemic. Further information attached to this document.

It is now the responsibility of Victoria Police to serve these lawful documents to the defendant so ordered by the court, and o ordered by the people and the people's jury.



**It is hereby ordered** that after a unanimous decision of the Court that **the Defendant be incarcerated** for a period of **25 years without parole**. It is further ordered that the defendant be removed from his position immediately. Severity of punishment equals the fact his actions have contributed to the genocide of the people of Victoria due to his activities as Health Minister leading to unnecessary duress and suffering and possible suicides hence the term genocide.

A copy of orders issued by a lawful jury is attached to this document.

**It is further** ordered that the Plaintiff pay court costs of \$950.00 to be paid into the Common Law Court Foundation: Westpac BSB 033-380 Acc 642170.

**Any failure to comply** with these orders may be a criminal offence under Common Law and a crime against the people. Should anyone involved fail to comply with these orders they will be prosecuted under Common Law as every man and woman is held personally accountable for their own actions, in their private capacity.

These Court Orders are effective as of this date and will remain in force until they are complied with.

These orders are also issued under the authority of this Common Law Court and **jus gentium**, the Law of Nations.
